represented by Corrigan Communicatie BVBA, with registered office at 2018 Antwerpen, Van Putlei 38, and registered with the CBE under BE0466.293.252, represented by Mrs. Karen Corrigan.

2. What is Humanity Wall ?

Happiness Brussels BVBA wants to encourage news outlets to replace their paywalls, allowing the reader to access full content of news articles after payment of a fee, by 'Humanity Walls'. A Humanity Wall allows access to the full article after the reader provides a donation for a charity. Only news articles which relate to a humanitarian crisis will be

eligible for a Humanity Wall. The charity chosen will be linked to the content of the news article, which means that the charity will raise money for the humanitarian crisis discussed in the news article.

3. Terms of use of the Website

Happiness Brussels BVBA (**'Happiness Brussels'**, **'we'** or **'our'**) agrees to provide you (**'you'** or **'the User'**) with the services that are available on the Website, subject to your compliance with these terms and conditions of access and use (**'Terms of Use'**).

3.1. Definitions

User : The User is any person who uses the Website or any of the services offered by the Website.

User Content : The term 'User Content' means the data transmitted by the User in the different sections of the Website.

3.2. Description of the use of the Website

The Website is available in English only.

Happiness Brussels provides via this Website the following facilities to the Users, enabling them primarily:

- to fill in a form to request more information on the Services; and
- to access Happiness Brussels content.

The Users may receive more information on the Services as follows:

1. Fill in the electronic registration form;
2. Check that the data you have provided is correct and rectify any errors before finally confirming your subscription by clicking on 'SEND';
3. Acknowledge that by clicking on 'SEND' you have read the Privacy Policy;
4. A screen will appear stating 'Thank you for your interest';
5. An e-mail will be sent to you confirming your request.

Once you have sent a request for information, we will contact you to provide you all the necessary information in relation thereto.

By filling in and sending the registration form you only request information on Humanity Wall and do not apply to participate in Humanity Wall. Eligibility for participation is not guaranteed. Participation to Humanity Wall is subject to entering into an agreement with **Happiness Brussels BVBA** laying down the terms and conditions of use of the Humanity Wall services, the Humanity Wall logo and the open software provided by Happiness Brussels .

3.3. Terms of access to the Website

The Website is accessible free of charge to any User who has access to the internet.

Any costs relating to access to the Website, whether charges for equipment, software or internet access, are for the User's expense.

Happiness Brussels reserves the right to unilaterally deny access to the Website and the services it provides without prior notification to any User who does not comply with any provision of the **Terms of Use**.

The User is solely responsible for the proper functioning of his or her IT equipment and entirely for his or her internet access.
